Seeking to raise a minimum of \$30 million and a maximum of \$33 million in common stock, the Bank began an initial public offering during the second half of 2017 and closed the offering with \$33 million. The Bank partnered with B. Riley FBR, Inc., a full-service investment-bank, to successfully complete the capital raise. Once the offering was closed, the Bank received all necessary approvals from both the state and federal regulatory agencies.

With its opening, Infinity Bank becomes only the 9<sup>th</sup> bank in the United States to open since 2008. Founder & CEO, K.P. (Bala) Balkrishna stated, “Today is an important day for the small business community in Southern California. With a new community bank comes a renewed focus on the unique needs of our target clients. With so many locally-owned banks purchased in the past several years, we see a great opportunity to fill a gap like only a community bank can.”
